## **CIRCULAR**

Sub: Election of members to the Managing Committee of the Association for 3 years (2018-2021).

As per the Memorandum of association of the Association, the term of Managing Committee is of three years. The term of the present Managing Committee will expire on 31<sup>st</sup> March, 2018. A new Managing Committee of 11 Members has to be elected for three years from 2018 to 2021. Members of the outgoing Managing Committee are entitled to seek re-election to the new Managing Committee, if they so desire.

2. The schedule for the election is as under-

b)	Scrutiny of nomination papers received.	May 15, 2018 - 5 PM
c)	Display of provisional list of Candidates	May 16, 2018 - 6 PM
d)	Last date for withdrawal of Candidates	May 18, 2018 - 6 PM
e)	Display of final list of candidate	May 19, 2018 - 5 PM

- 3. If the number of valid nominations of candidates in the final list are equal to the number of nominated candidates in the Managing Committee i.e. 11, the Election Officer will declare them elected unopposed.
- 4. If the valid nominations of candidates in the final list of candidates are more than 11, election will be held, as per the schedule above. Voting will be by ballot only. After counting of votes completed, the Election Officer will declare the names of 11, successful candidates who will form the new Managing Committee of the Association for 2018-21, subject to the approval of Annual General Body of 2017-18.
- 5. If the valid nominations of candidates in the final list is less than 11, the Election Officer will declare them elected unopposed as the member of the Managing Committee and election will be held for the remaining vacancies on the Managing Committee in the Annual General Meeting of 2017-18. The above elected members unopposed shall be subject to approval of the Annual General Body 2017-18.

- 6. The Election Officer will invite fresh nominations for these vacancles at the Annual General Meeting itself. If the number of nominations received is equal to the number of vacancies, no election will be held and the Election Officer will declare these candidates elected unopposed and also declare the list of 11, candidates who will form the new Managing Committee for 2018-21.
- 7. If the number of nominations received in the Annual General Meeting is more than the number of vacancies, elections will be held by ballot at the beginning of the meeting. After the counting of votes is completed, the Election Officer will declare the names of successful candidates and also declare the names of 11, successful candidates who will form the new Managing Committee for 2018-21 of the Association.
- 8. If the number of nominations received in the Annual General Meeting is less than the number of vacancies, the Election Officer will declare the names of candidates who have been elected unopposed and also declare the names of candidates who have been successfully elected to the new Managing Committee for 3 years.
- 9. A copy of the Nomination form is enclosed. Completed forms should be sent to the Election Officer on the above address in time. Nomination forms received thereafter, though may be valid, will not be considered.

## Notes

- 1) The nomination form should be filled in by the member only and duly proposed and seconded by the members only who are the registered members as on 28.02.2018.
- 2) Nominations must be sent in the prescribed nomination form.
- 3) Nomination papers received late, i.e. after 5 p.m. on May 15, 2018, will be invalid and will not be taken into account for the purpose of the election.
- 4) Nomination papers which are incomplete in any way will be invalid and will not be taken into account for the purposes of the election.
- 5) The Election Officer will have the right to decide if withdrawal of candidature after the prescribed date for withdrawal should be allowed.
